

BABSON COLLEGE
GUEST SPEAKER AGREEMENT

This agreement (“Agreement”) is made and entered into by and between Babson College (“College”) and _____ the (“Speaker”) for the personal services (the “Event”) of the Speaker. In consideration of the agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. The name and location of the Event: _____
2. Date/Time of the Event: _____
3. In consideration of the Event performed by Speaker pursuant to this Agreement, the College shall pay to Speaker in US dollars the one-time sum of \$_____ within 35 days following the conclusion of the Event. Payment will be made by a College check or in such other form as the College may require payable to the Speaker less all applicable U.S. state and federal income tax and withholding and other amounts.
4. The College shall have 100% control over all announcements, advertising and other promotion relating to the Event, if any. In connection with the Event, Speaker hereby grants at no cost to College permission to use, publish, copy and redistribute the name, image, likeness, biography and other marketing materials and information of Speaker provided to College by Speaker. In addition, College may film, photograph and otherwise record in any medium (now existing or hereafter created) Speaker in connection with the Event. Speaker hereby grants to College an irrevocable, fully paid up, world-wide license to use and/or display in whole or in part such recordings in connection with the nonprofit, educational and/or research purposes of the College.
5. The status of Speaker shall be that of an independent contractor and not that of any employee, agent or other partner of the College. The College shall have no obligation to make any payment or reimbursement for any expenses, fees or other amounts incurred in connection with this Agreement except for the payment stated in Section 3 of this Agreement.
6. The validity, construction, interpretation and all other matters relating to this Agreement and/or any other disputes between the parties shall be governed by and interpreted in accordance with the laws of the Commonwealth of Massachusetts. Notwithstanding any provision in this Agreement, nothing in this Agreement shall expand the liability of College beyond the limitations and exclusions otherwise applicable to Babson College under the charitable immunity statutes of Massachusetts.
7. This Agreement contains the entire agreement between the parties and may not be modified except in writing, signed by both parties and attached hereto. This Agreement supersedes all prior communications, understandings and agreements, whether oral or written, between the College and Speaker with respect to the subject matter hereof. Speaker may not assign or transfer any of its obligations under this Agreement without the prior written consent of the College.
