Please find listed below the process for applying for need-based financial aid if you plan to take a Summer Session 2023 course at Babson and need financing options.

Financial aid applicants should complete page 2 of this form and submit it to SFS by **April 3, 2023**. Save a copy of page 2 with your name included in the file and email a copy to [sfs@babson.edu](mailto:sfs@babson.edu). If you have any questions related to financing options or submitting the form, you can email your SFS counselor for assistance or reach out to SFS at [sfs@babson.edu](mailto:sfs@babson.edu). Please note the following:

- Financial aid applicants must complete their 2023-2024 financial aid application by **April 3, 2023**. Your 2023-2024 financial aid package, including summer, will be available by April 19, 2023. You can confirm the status of your 2023-2024 file using the [Babson Hub](#).
- Payment for summer, including any financial aid, is due on Monday, **May 1, 2023**. Your summer registration will be at risk of cancellation prior to the start of classes if payment is not received on a timely basis.
- Funding is limited; students who plan to take 6 or more credits during the summer will typically have more financial aid options available to them as many programs require half-time attendance (6 or more credits). We are unable to provide institutional funding for repeated or substituted courses due to a failure or withdrawal from a course.
  - Students who receive full-tuition scholarships (*Posse, Diversity Leadership, Weissman, Global Scholars, Enrico, Baldwin Richardson, NFTE, AMBSEL*): Your award covers full-tuition up to 8 semesters, plus two courses.
  - Federal Direct Loan: If you will be enrolled in 6 or more credits during the summer and are a U.S. citizen /Permanent Resident, you can borrow through the Federal Direct Loan program.
  - Supplemental Loans: If you have borrowed supplemental loans in prior semesters, that may be an option for summer as well. You can find additional loan information on our website at [www.elmselect.com](http://www.elmselect.com).

May 1, 2023	Payment for Summer Session 2023 is due.
